SECRETARIES: Please read at the first stated meeting after receipt and make it available to those who are interested.

Dear Worthy Matron, Worthy Patron, Past Matrons, Past Patrons and District Instructors:

The Board of Examiners will be conducting the examinations for those who are interested in serving Minnesota Grand Chapter as a District Instructor. Anyone who has served as a Worthy Matron or Worthy Patron is eligible. Those Sisters and Brothers who satisfactorily complete the test and attend the Worthy Grand Matron's School of Instruction will be qualified to receive an appointment from the Worthy Grand Matron to serve as a District Instructor. The Worthy Grand Matron's School of Instruction is typically held the first Saturday after the annual Grand Chapter Session.

The District Instructor examination will consist of two parts: an oral examination and a written test. A Study Guide is available (by mail or email) from Sister Judy Luettjohann, Chairman of the Board of Examiners.

The exam will be given (at a place to be decided) on Friday and Saturday March 11 and 12, 2022. Times will be specifically scheduled for each candidate. You must contact Judy Luettjohann, Chairman of the Board of Examiners, by February 21, 2022 for an appointment to take the DI examination, so that we may schedule appropriately.

Being a District Instructor can be a very rewarding experience as well as being a great service to our Order. While members of the Board of Examiners cannot provide direct assistance in preparing candidates for the exam, any member is willing to answer questions or assist candidates in locating current District Instructors to serve as mentors or study partners.

Also, any Past Matrons or Past Patrons of the Grand Chapter of Minnesota who are interested in filing for the office of Associate Grand Conductress should contact Judy Luettjohann, Chairman of the Board of Examiners. A separate study guide for the examination of candidates for the office of Associate Grand Conductress is available (by mail or email), and Judy will be happy to supply you with it, and answer any questions you may have.

The examination for Associate Grand Conductress is also in two parts, an oral examination and a written test. It is similar to the District Instructor examination, but contains a few additional written questions regarding our Constitution and Laws. The examination for Associate Grand Conductress candidates will be held Friday, March 11, 2022 (at a place to be decided). You must contact Judy Luettjohann, Chairman of the Board of Examiners by **February 21, 2022** for an appointment to take the examination for Associate Grand Conductress.

We do hope you will consider both of these opportunities to serve our Order and our members.
